In this regard, I am directed to inform you that this University has no objection for allotment of students to the aforesaid colleges subject to the fulfillment of the following terms conditions of the state Govt./ NCTE and University Rules & Regulations:-

समस्त प्रवेश केन्द्रीकृत व्यवस्था के अन्तर्गत वर्धमान महावीर खुला विश्वविद्यालय, कोटा के माध्यम से पीटीईटी परीक्षा में सम्मिलित छात्रों में से मैरिट के आधार पर प्रवेश दिये जायेंगे।

- महाविद्यालय राज्य सरकार द्वारा निर्धारित शिक्षण शुल्क के अतिरिक्त किसी भी प्रकार की कोई राशि छात्रों से नहीं ली जावेगी। यदि इस संबंध में किसी प्रकार की शिकायत प्राप्त होती है, तो संबंधित महाविद्यालय की मान्यता को निरस्त करने की कार्यवाही की जा सकती है।
- महाविद्यालय को एनसीटीई एवं राज्य सरकार द्वारा निर्धारित सभी मापदण्डों की पूर्ति करना अत्यावश्यक होगा तथा समय-समय पर जारी आदेश की पालना करनी होगी।
- महाविद्यालयों द्वारा उपयुक्त योग्यताधारी शिक्षकों की उपलब्धता की सुनिश्चितता की जावेगी।
- निजी शिक्षक प्रशिक्षण महाविद्यालय स्वयं की वेबसाइट निर्मित कर महाविद्यालय से संबंधित निम्नलिखित सूचना वेबसाइट पर अपलोड करना सुनिश्चित करेगी।

As per University Rules and Regulations, the College will have to follow the Following terms & Conditions:

- These colleges will have to complete all the requirement/ formalities for running B.Ed. colleges as per the norms laid down by the NCTE/ UGC/State Government and University Affiliation rules.
- Qualified Principal and faculty is to be appointed as per the NCTE norms and University rules.
- These Colleges should have Library, Laboratories, Computer Lab and other infrastructure requirement as per the NCTE and University norms.
- The University Inspection Committee will inspect/re-inspect the college and if the proper requirements are not found, the above permission shall be treated as withdrawn.
- This NOC is purely provisional and subject to the fulfillment of all the conditions laid down by the NCTE, State Government and University Affiliation rules.

The University has legal rights to withdraw affiliation of the college any time, if the conditions are not found satisfactory.

7. These colleges if not found proper will have to go through re-inspection and the re-inspection fee will to be deposited by the concerned colleges within a month to complete the deficiencies pointed out to them.
8. All the requirements will have to be completed within one month's time.

If the infrastructure and Faculty in the College is not found proper in accordance with the affiliation rules/ NCTE norms / State Govt. norms, during the course of inspection, the College shall be subject to dis- affiliation and the students of such College shall be transferred to some other Colleges.


